Assessment activities of the impacted wetlands have been completed and in 2004 Raytheon completed an aggressive wetland excavation and restoration program. Summary

Immediate Response Action Completion Report

(430 Boston Post Road, Wayland, MA (the "Site"), Permit No. 133939)

Raytheon Company will be submitting an Immediate Response Action (IRA) Completion Report to the Massachusetts Department of Environmental Protection (DEP) concluding the need for further immediate response actions on the wetland portion of the Site. Future activities will be conducted under the Phase IV - Remedy Implementation Plan activities, previously submitted.

The following provides a summary of IRA activities:

- Raytheon Company submitted an IRA Plan to the DEP on June 26, 2000 to address the
 potential Imminent Hazard condition associated with the observed stressed vegetation in the
 wetland portion of the Site.
- The IRA Plan consisted of delineating the extent and nature of the impact to the wetlands, characterizing the wetland habitat, and conducting an Imminent Hazard Evaluation.
- Assessment activities of the wetlands were conducted in accordance with the Phase II Scope of Work and the Phase II Scope of Work - Addendum No. 1.
- Characterization of the wetland habitat included mapping of wetland vegetation, compiling Site specific environmental receptors and the collection of plant tissue.
- The Imminent Hazard Evaluation concluded the following:
 - Conditions at the site do not pose a potential Imminent Hazard to human health.
 - Conditions at the site do not pose a potential Imminent Hazard to public safety.
 - Conditions at the wetland portion of Site pose a potential Imminent Hazard to the environment.
- Assessment activities have been completed at the Site and were documented in the Phase II and Phase IV reports.
- In accordance with the Phase IV, excavation of approximately two-acres of impacted wetland soil/sediment, transportation excavated material off-Site for disposal, and restoration of the wetland were initiated in October 2003.
- Comprehensive response actions are being implemented in accordance with the Phase IV and should be completed during the Summer 2004. Information regarding ongoing activities will be included in the Phase IV completion report and permit closure documentation.

The assessment activities associated with the IRA have been completed and the results were shared at several public meetings and can be found in the Phase II - Comprehensive Site Assessment and Phase IV, previously submitted to the DEP. A more detailed summary of the draft IRA Completion Report can be found at the Wayland Public Library and the Wayland Board of Health and the Web Site.
