On November 24, 2002, Raytheon Company (Raytheon) submitted for public comment a draft Phase IV – Remedy Implementation Plan (Phase IV) outlining the design and construction of clean-up plans for the Site. Based on feedback from the Public Involvement Plan (PIP) participants, Raytheon has made some preliminary revisions to the Phase IV and has submitted it to the Massachusetts Department of Environmental Protection (DEP). A summary of the Phase IV is enclosed and a copy of it is available at the Wayland Public Library and the Wayland Board of Health Office. A more detailed response to public comments will be submitted separately. A summary of the report is enclosed. A copy of the Phase IV is available for your review at the public repositories located at the Wayland Public Library and the Wayland Board of Health Office. 

As discussed at the December 12, 2002 public meeting, Raytheon has submitted a Release Notification Form (RNF) to the DEP for the northern portion of the Site to allow for additional assessment activities. By separating this northern area, it will allow Raytheon to continue with its proposed cleanup plans for the rest of the Site, while still investigating the northern portion of the Site. As to keep the public informed, Raytheon will incorporate the investigation of the northern portion of Site into the existing Public Involvement Plan (PIP). As the assessment activities proceed, the results will be shared with the PIP at a PIP meeting and documented for public comment.

Summary
Phase IV – Remedy Implementation Plan
(430 Boston Post Road, Wayland, MA (the “Site”), RTN 3-13574)

Raytheon Company has submitted a Phase IV – Remedy Implementation Plan (Phase IV) to the Massachusetts Department of Environmental Protection (DEP). The Phase IV summarizes the design and construction of clean-up plans for the Site. However, based on preliminary data, the northern portion of the Site will require additional assessment activities. Raytheon has submitted a separate Release Notification Form (RNF) to the DEP for the northern portion of the Site to allow for this additional assessment work and future regulatory submittals.

The following summarizes the Phase IV:

- ◆ Summary of assessment activities conducted in the northern portion of the Site to date.
- ◆ Summary of the in-situ chemical oxidation pilot study.
- ◆ Proposed clean-up plan for wetlands sediment:
 - ◆ Excavation and restoration
- ◆ Proposed clean-up plan for the groundwater (southern portion of the Site):
 - ◆ Chemical Oxidation
- ◆ Conceptual design of the remediation and restoration of wetland, including excavation, management of remedial waste, restoration of wetland and monitoring of progress of regrowth of wetland species.
- ◆ Overview of the permitting process for the proposed wetlands excavation including DEP, Army Corps of Engineers and the Town of Wayland Conservation Commission among others.
- ◆ A revised verification sampling plan and closure documents to ensure clean-up and wetland replication goals are met.
- ◆ Tentative schedule for implementation of Phase IV.
