

Based on our ongoing discussions for addressing this expanding site investigation, we agreed the most efficient solution is to circulate the attached PIP petition as I had volunteered to do. It is also my understanding the November 2000 PIP already in place for multiple RTN numbers will be modified per MCP regulations to accommodate the expanding area. Stakeholders will have the opportunity to weigh in with comments, updated information, etc., while Raytheon amends the PIP to incorporate the Northern Area.

I believe most signatories on the attached petition are already on your PIP mailing list. It is my intent to submit to you, within a week and under separate cover, my personal suggested amendments to the PIP which we have already discussed. According to DEP website PIP guidance documents and your March 3 PIP meeting presentation, upon receipt of this petition, Raytheon will proceed to inform the public about required action steps.
