Dear Mr. Jeff Ritter:

Raytheon Company will hold a public meeting on October 6, 2004 to summarize the construction design and results from the clean-up activities for groundwater in the "Southern Area" of the Site and the wetland portion of the Site. The meeting is scheduled at 7:30 p.m. in the Senior Center adjacent to the Wayland Town Building. An agenda for the public meeting is enclosed. A draft Phase IV Remedy Implementation Plan Completion Report will be submitted for public comment prior to the meeting summarizing in detail the construction design and results of the remediation activities.

As you may recall, an in-situ chemical oxidation (ISCO) was chosen as the remedy of choice to treat the chlorinated volatile organic compounds (CVOCs) in groundwater in the southern portion of the Site. ISCO is a process that breaks down CVOCs in the groundwater into harmless end-products, such as carbon dioxide, water and chloride. A chemical oxidant is injected into the ground to stimulate the chemical breakdown. The entire process, which takes place below ground, is safe to the environment.

In addition, approximately two-acres of impacted wetlands was excavated and restored at the Site. A summary of those activities will be discussed at the meeting. Raytheon will soon be transitioning into monitoring the survivability of the different plant species in the restored area.

Raytheon is committed to improving and protecting the environment and natural resources in your community.
